TO: ALL PARTICIPATING LENDERS

SUBJECT: HARFORD AND CECIL COUNTIES REGIONAL SPECIAL

We are pleased to announce that, effective June 10, 2014, we are offering a special interest rate for borrowers who are purchasing a home in Harford or Cecil Counties. The interest rate in these counties will be **25 bps (1/4%) below** our regular MMP interest rates for both Conventional and Government loans. The Harford and Cecil Counties Regional Special will run through close of business on **August 11, 2014.**

Please note that the reduced interest rates are applicable for eligible new reservations only and may not be used in conjunction with our REO program or any of the refinancing programs.

However, for reservations made on or after June 1, 2014, borrowers may be eligible for a mortgage credit certificate under CDA's **Maryland HomeCredit Program** if they meet the requirements detailed on our website at http://mmp.maryland.gov/Pages/MDHomeCredit.aspx and the lender is on the approved lender list to offer mortgage credit certificates
