TO: PARTICIPATING LENDERS

SUBJECT: OPENING OF THE WESTERN MARYLAND DOUBLEPLAY PROGRAM

We are pleased to announce that, effective May 13, 2015, we are offering special incentives for borrowers who are purchasing a home in one of the following counties: Allegany, Frederick, Garrett and Washington. The Western Maryland DoublePlay program will run through close of business on **July 13, 2015**. Highlights of the program are:

- The interest rate is 25 bps (0.25%) below each of the regular MMP interest rates for conventional and government insured loans. The interest rate reduction <u>cannot</u> be used in conjunction with the Maryland HomeFront Program, the No DPA program, the "You've Earned It" program or a Refinance program. Each of these programs carries its own special interest rate.
- The Maryland Home Credit Program (MHCP) can be used in conjunction with Western Maryland DoublePlay
 program. CDA will waive the fee for a Mortgage Credit Certificate (MCC) associated with a DoublePlay loan.
